WAIVER OF LIABILITY FOR THE 2026 Friends of Tewksbury Tennis (“FTT”) Tewksbury OPEN Tennis Tournament.

PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS In consideration of permission to use the property, facilities, equipment, and/or services of the Town of Tewksbury located at 320 Pleasant St. Tewksbury, Massachusetts, I do for myself, my heirs, personal representatives, and/or assigns, hereby release, waive, discharge, and agree not to sue the Town of Tewksbury or the FTT, its directors, officers, employees, servants and/or agents of and from liability, or negligence by the Town of Tewksbury or the FTT, resulting in personal injury, accidents or illness (including death) and property loss arising from, but not limited to, participation in activities and use of facilities and the use of the Tewksbury Memorial High School premises. I further recognize that physical activity, by its very nature, carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The FTT uses the Town of Tewksbury facilities for tennis activities. I understand that tennis is a HAZARDOUS activity, and that the risks inherent in the sport of tennis include (but are not limited to) paralyzing injuries and death. Nevertheless, I hereby assert that my participation in any and all such activities is voluntary and that I knowingly assume all such risks. I also agree to INDEMNIFY AND HOLD THE FTT and the Town of Tewksbury HARMLESS from any and all claims, actions, suits, demands, costs, expenses, damages and liability (including attorney fees) brought as a result of my involvement at the FTT Tennis OPEN. The undersigned further expressly agrees that the foregoing Waiver is intended to be as broad and inclusive as is permitted by the laws of the Commonwealth of Massachusetts, and that if any portion of this Waiver is held invalid, it is further agreed that the remaining portions of the Waiver will continue in full legal force and effect. I HAVE CAREFULLY READ THE ABOVE, FULLY UNDERSTAND ALL TERMS CONTAINED HEREIN, UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS (INCLUDING MY RIGHT TO SUE), ACKNOWLEDGE THAT I AM SIGNING THIS AGREEMENT FREELY AND VOLUNTARILY, AND INTEND BY MY SIGNATURE TO GIVE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW FOR MYSELF AND (IF APPLICABLE) MY MINOR CHILD OR CHILDREN.
